WHEREAS, REGULATION 10-Board of Trustees, Section 10(g) of the <u>Laws of Masonry in West Virginia</u> (15th Edition 2005, Revised October 14, 2008) currently reads as follows, to wit:

(g) The Treasurer shall faithfully keep all evidences of deposit of moneys, investments, policies of insurance, evidence of title to property of the Grand Lodge, and all moneys receivable from time to time by the Board, and account therefore annually, and comply with all orders of the Grand Lodge at each annual communication with respect thereto; and pay over and deliver to his successor in office all property of the Board in his hands when so ordered by the Board or by the Grand Lodge. He shall furnish bond payable to the Board in penalty sufficient to secure moneys and property received by him, with surety to be approved by the Board, and conditioned to pay and account for all moneys and property coming into his hands as such treasurer, expense of such bond to be paid by the Board. The treasurer shall receive for his services \$300.00 per annum; and,

WHEREAS, the complexities of the Grand Lodge's current investment portfolio and management thereof by the Board's Treasurer, combined with his increased accounting duties and responsibilities regarding the administration of Grand Lodge's assets as a whole, has resulted in an ordinate increase in the amount of time the Board's Treasurer has to expend on the business of the Board of Trustees; and,

WHEREAS, for all of the forgoing reasons the Board of Trustees feel and believe that its Treasurer should receive an increase in the amount paid to him for his invaluable services to the Board and to the Grand Lodge as a whole.

NOW THEREFORE, BE IT RESOLVED that REGULATION 10-Board of Trustees, Section 10(g) of the <u>Laws of Masonry in West Virginia</u> (15th Edition 2005, Revised October 14, 2008) be changed to read as follows, to wit:

(g) The Treasurer shall faithfully keep all evidences of deposit of moneys, investments, policies of insurance, evidence of title to property of the Grand Lodge, and all moneys receivable from time to time by the Board, and account therefore annually, and comply with all orders of the Grand Lodge at each annual communication with respect thereto; and pay over and deliver to his successor in office all property of the Board in his hands when so ordered by the Board or by the Grand Lodge. He shall furnish bond payable to the Board in penalty sufficient to secure moneys and property received by him, with surety to be approved by the Board, and conditioned to pay and account for all moneys and property coming into his hands as such treasurer, expense of such bond to be paid by the Board. The treasurer shall receive for his services \$3,000.00 per annum.

PROPOSED AMENDMENTS (LAID OVER ONE YEAR)

RESOLUTION

Re: Masonic Law 24.I.7 - presently reads:

"No circular letter or request for contributions for the benefit of any Lodge or individual can be sent by one Lodge to another without the consent of the Grand Master"

In order to

- (a) extend this rule to electronic modes of communication, and
- (b) assure there is written documentation of such consent,

I propose it be considered that Masonic Law 24.I.7 be amended to read:

"No request for contributions can be sent by one Lodge to another except by written consent of the Grand Master."

APPROVED

RESOLUTION

Re: Masonic Law 46.23 - presently reads:

"No vendor, company, organization, or anyone else may be supplied our individual membership list to be used for other than our own particular Lodge or Grand Lodge purposes without first obtaining the consent of the Grand Lodge or Grand Master. Further, any such person, business, or organization to which the individual membership list is to be supplied must first execute his or its guarantee, in writing, that such membership list (1) shall only be used for the single purpose for which it is supplied; (2) shall not be further copied or distributed, and (3) shall be forthwith returned to the Grand Secretary upon completion of its intended use."

The phrase "or anyone else" in the first sentence would appear to include every Lodge in our Grand Jurisdiction, along with vendors, companies, and organizations.

To assure the

- (a) our M.W. Grand Master authorizes every such distribution, and
- (b) there is written documentation of such consent,

I propose it be considered that the phrase,

"...without first obtaining the consent of the Grand Lodge or Grand Master,"

in Masonic Law 46.23 be amended to read:

"...without first obtaining the written consent of the Grand Master." APPROVED

RESOLUTION

Be it further resolved that we host in the normal rotation, the Annual Communication of the Southeastern Conference of Grand Masters. APPROVED
